Are you planning to have your Will written or updated soon? We recommend you complete this checklist and have it ready for your appointment – whether that's with a local solicitor, online or over the phone. It will capture a lot of the information your solicitor will need to know.

- Specific an item such as a piece of jewellery.
- Pecuniary a set amount of money.
- **Residuary** a percentage of your estate.
- **Beneficiaries** People and organisations who you include a gift to in your Will.
- **Bequest/Legacy** A gift left in your Will to a person or charity.
