Pan-London End of Life Alliance -Terms of Reference

1. Purpose of Pan-London End of Life Alliance

Rationale

- Despite an overall picture of improvement nationally, it is recognised that there is significant scope for further improving end of life experiences of individuals, carers and their families.
- The quality of end of life care received in London currently under-performs against national averages. ONS Survey of Bereaved People VOICES, 2011-12 and Health and Social Care Information Centre, Carers survey, 2012-12 data demonstrate that:
 - 26% of bereaved relatives in London rated the care they received from GPs as excellent compared with the national average of 35%.
 - 34% of bereaved relatives in London rated the care they received from district and community nurses as excellent compared with the national average of 45%.
 - 66% of carers in London felt they were included or consulted in decisions compared to the national average of 73%.
- There is also considerable variation in the quality of care within London. ONS Survey of Bereaved People VOICES, 2011-12 data demonstrated that:
 - London scored that best (Islington) and worst (Newham and Waltham Forest) in the country in terms of overall quality of care in the last three months of life.

Aims of the Pan-London End of Life Alliance

 The Pan-London End of Life Alliance is an initiative led by like minded people and organisations working to improve the care that people living with a terminal illness and their families receive in the capital.











2. Structure of the Pan-London End of Life Alliance

Overarching approach

• The Pan-London End of Life Alliance itself is an inclusive membership for self-selected representatives who have a contribution to make to this agenda – consisting of wide representation from across health, social care, voluntary and education sectors, as well as individuals who can speak on behalf of families and others who have experience of terminal illness The Alliance members will be supported by an Executive Steering Group.

• The Pan-London End of Life Alliance Executive Steering Group which is led in partnership by senior representatives from across health, social care and voluntary sectors provides oversight from a system wide perspective to facilitate bringing together the efforts underway across London.

- The role of the Pan-London End of Life Alliance Executive Steering Group, which includes representation from each of these pan-London wide networks is to facilitate:
 - A system leadership approach;
 - The exchange of progress across partnership networks and to engender trust;
 - Work in conjunction with the pan-London networks to support aligning efforts and reduce complexity;
 - To act as an independent integrated collaboration to influence and lobby for positive change;
 - To identify what needs to be addressed from a London-wide perspective to improve End of Life care across the capital and establish which parties are best leading these efforts:
 - Blue sky thinking aimed at striving for excellence and equality in End of Life care across London.

4. Review of Terms of Reference

 The Terms of Reference will be reviewed on an annual basis as a Standing Agenda Item at the Executive Steering Group meeting.
